### OVERVIEW:

This two-day workshop will provide participants who have completed EMDR basic training with an introduction to Structural Dissociation and Ego State Therapy theory and when it is useful or necessary to use these two frameworks with clients being treated within an EMDR/Adaptive Information Processing Approach. From an AIP perspective, ego states are distinct neuronal networks in the brain. Each has a more or less distinct sense of self. Participants will leave the workshop with experience using the Dissociative Table and ten specific tools to facilitate work with clients' aspects of selves.

**SEMINAR DESCRIPTION CONTINUED:**

Each day will feature a lecture format in the morning. Both afternoons will begin with a live demonstration of the Dissociative Table Technique with a volunteer. Then participants will have the supervised practicum opportunity to work in triads learning to use the Dissociative Table Technique (often called the Conference Room or Meeting Place) for themselves, as well as case consultation on child, adolescent and adult clients with complex PTSD and dissociative diagnoses other than DID. (Dissociative Identity Disorder will be addressed in the additional Monday workshop.) These complex clients can be treated successfully using modifications of the EMDR Protocol but without deviation in Phases 3-6.

Participants will be strongly encouraged to complete recommended readings, sent by email, before the workshop. These include powerful transcripts of actual Ego State Therapy sessions with my clients, used with permission.

**Farnsworth Lobenstine, LICSW** is on the national faculty of the EMDR Institute, serving since 2001 as a Facilitator. He has been an EMDRIA Approved Consultant since 2003 and a Trauma Recovery (HAP) Facilitator since 2005. For the tenth year he is teaching an academic year-long Advanced Seminar on the Integration of Structural Dissociation and Ego State Therapy with EMDR Therapy in Western Massachusetts. Farnsworth began his study of Ego State Therapy and dissociation in 2001. Since 2013, he has presented sold out workshops around the country.



He co-authored a lengthy article published in the Journal of EMDR Practice and Research in 2013 on his highly successful brief, intensive treatment, using EMDR and Ego State Therapy with a woman who had been hospitalized.
